The Omnium Champlain will be governed by the rules as defined in The Racing Rules of Sailing ("R.R.S.") 2017-2019 (ISAF) except as modified by this Notice of Race or in the Race Instructions

Classes:

Racing PHRF (spinnaker) A-B
Cruising PHRF (jib and main) C-D
Additional class may be added.

Registration and fees

Registration can be submitted on-line on the internet web site www.omniumchamplain.org **OR** under the tent at Plattsburgh City Marina from 5 PM to 8 PM on 2017-08-25.

Entry is not complete until the Organizing Authority receives a Waiver and Release of Liability from each skipper and crew member. Skipper's waivers are submitted during the entry process.

The subscription fees for the Omnium Champlain is \$75.00 USD paid in cash or by check (to Omnium Champlain) or Paypal payment on the Omnium Champlain web site www.omniumchamplain.org **OR** \$85.00 USD for payment received under the tent at Plattsburgh City Marina. Subscription fees shall be received before 8 PM on 2017-08-25.

Each boat registration include a ticket for the BBQ and souvenirs draw.
Additional BBQ ticket are available at \$15.00 USD.

RADIO VHF : During the race the communication will be on channel 80. «It is recommended to monitor the channel 16 and the channel 80 if the radio has that feature.
